Oral presentations: (20-30min) Research & Policy presentations and Experience/Practice-oriented presentations

□ **Panels** (60-90 min) are teams of presenters (three to five) bringing a variety of perspectives to a specific topic, initiative or experience. Panels should allow for a maximum of two thirds time for combined presentation time and one third for audience engagement. Each panel should have an organizer or lead (e.g. moderator); this person should submit the abstract and will be the contact person.

□ Workshops (60-90 min) provide a focused educational opportunity for participants and can follow a variety of formats, depending on their learning objectives.

□ Collaborative sessions (60-90 min) are facilitated, participatory sessions focusing on particular issues or topics, organized to discuss ideas, analyze challenges, and collaboratively build solutions. Each collaborative session should have an organizer or lead (e.g. moderator); this person should submit the abstract and will be the contact person.

Poster Presentation: Posters cannot exceed 6' by 3' in size and should be printed in landscape format.

Abstract title:

All abstracts or descriptions should be 250 words or less.

Research and policy oral presentation abstracts should follow the format: background; aim; methods; results; conclusions; and indicate any potential conflict of interest.

Experience/practice oral presentation abstracts should include the objective(s) of the presentation, the description of the experience, and findings and recommendations, whenever relevant.

Panel/Workshop/Collaborative session abstracts should follow the format: objective(s)/learning outcomes, following the format 'By the end of the sessions, the participants will be able to...'; structure; participants; facilitation; and, targeted audience (if you feel the session caters to the need of a particular segment of attendants such as, among others, researchers, policy makers, community workers, migrant workers).

The format of abstracts for poster presentations is identical to the one for oral presentations belonging to the same track (research; policy; experience/practice).
