Greetings!

Thank you for participating in the McIntyre Powder Project (MPP) at the Occupational Health Clinics for Ontario Workers, Inc. (OHCOW). This newsletter provides you with highlights of our ongoing work with the McIntyre Powder-exposed group of mine workers over the past year.

New Research - Cardiovascular Disease and McIntyre Powder

A new study that was published in the American Journal of Industrial Medicine in August 2024 compared the rates of cardiovascular disease (diseases of the heart and blood vessels) in mine workers who were exposed to McIntyre Powder and mine workers who were not exposed to it. The study found higher rates of the following types of cardiovascular disease in McIntyre Powder-exposed mine workers, with risk generally increasing for those exposed for longer periods:

- Acute Myocardial Infarcts (heart attacks)
- Ischemic heart disease
- Congestive heart failure

We continue to assist workers or their Estates to complete the initial paperwork to start new individual WSIB claims, or to request that the WSIB reconsider their original decision on claims that were denied in the past.
